#### Further comments:

The initiative to produce this document is welcomed and it incorporates improvements relative to an earlier document.

Whilst we do not object to what it seeks, we do feel that the document could be more proactive in setting out more specifically the detailed vision for better connecting the town of Staines with the nearby natural environment within the CVRP, in particular around Staines Moor and the two reservoirs to its east.

This is important as it can be reflected in projects that could feature in infrastructure improvement schedules that could benefit from developer contributions and which the CVRP could partner the Council in bidding for funds (e.g. National Lottery and Developer Contributions pots) and implementing projects.

We would welcome a detailed discussion about how this could be achieved before revisions are finalised to the Framework.
