Dear Mr Johnson and Ms Morrissey,

Thank you for sparing the time to visit the Colne valley Regional Park (CVRP) earlier this month. It was heartening to hear you talk about how important you think the Park is and your acknowledgement that it must be protected for the benefit of people and wildlife. We look forward to continuing that conversation with you, other local MPs and government ministers in the coming weeks and months.

The key to doing this as far as local residents and users of the CVRP are concerned, is tangible action to counter the rising tide of threats facing it. The key steps are:

- Halting the increasingly frequent exploitation of 'very special circumstances' and 'exceptional circumstances', justifying development in the Green Belt's most vulnerable part the urban fringe. Certainly, in the Colne Valley Regional Park the system has become a free for all and we are witnessing the loss of the Green Belt's long-term benefit for communities, the environment and the integrity of our countryside. Green Belt as a strategic policy, and a workable mechanism for cross-border planning is vital to deflect development pressures away from the Green Belt.
- Refocusing the way planning talks about Green Belt, emphasising its
  positive purpose and the considerable benefits it can bring for wildlife,
  food production, public access to the natural environment (with the health
  and wellbeing benefits this brings) and combatting climate change.
- Specific protection for the Colne Valley Regional Park. Its only defence to date has been the Green Belt which is now clearly beginning to crumble. If the Park is to survive, its protection must be underpinned by resources for restoration, proper planning and enforcement. We stand ready to play our part in finding creative solutions to these problems, but the starting point is the political will to effect change.
- Ensuring conscious co-ordination of planning across county boundaries and proper consideration and mitigation of the cumulative impact of multiple development proposals.

Its purpose is to raise awareness of the challenges facing the 'inner' Green Belt where development pressure is at its greatest, and to examine how the planning system can be speedily improved.

Thank you once again for taking the time and trouble to see some of the Colne Valley Regional Park for yourselves. We greatly look forward to meeting you again soon to explore the grave and urgent challenges facing the Green Belt and the Park in more depth.
