



## Closure of Grand Union Canal near Harefield Marina, Hillingdon; information for canal users, pedestrians, and cyclists

High Speed Two (HS2) is the new high speed railway for Britain. This notification is to give you information on the upcoming closure of the Grand Union Canal (GUC), and alternating closure of the London Loop or towpath from February 2024. This closure will enable AlignJV to construct the Colne Valley Viaduct, which will cross the GUC in Hillingdon.

### Information for canal boat users on GUC closure

On Thursday 1 February 2024, from 8am, we will close the canal and towpath in the morning and remove the existing waterpipe scaffold bridge by crane. Once this structure has been removed, we will begin the construction of the viaduct deck across the GUC using a large machine called a launching girder. This work will begin from the morning of Friday 2 February 2024 and is expected to take five weeks to complete. The canal will be closed to all boats at a point south of Harefield Marina.

Access to the marina will remain open but passage south towards Uxbridge will not be possible whilst construction takes place during the day and night. This is to ensure the safety of both users of the canal, pedestrians and construction workers. From mid-March we expect to be able to open the canal during the day for boats – closing only at nighttime – to ensure that canal movements are not limited out of normal stoppage season. Night closures will continue until early April 2024.

### Information for canal boat users, pedestrians and cyclists on the towpath and London Loop closure

We will need to temporarily close either the towpath or the London Loop, where the track is currently diverted over the temporary pontoon, whilst we construct over the canal. We will only close one of these routes at any one time, and full advance signage will be provided to guide residents and visitors to the alternative path.

From 8am Thursday 1 February to early April 2024

### What to expect

Closure of the Grand Union Canal to all boats at the southern end of Harefield Marina and alternating closure of the canal towpath or London Loop during construction of the Colne Valley Viaduct over the canal

Removal of the waterpipe scaffold bridge over the canal

### What we will do

Do all we can to minimise disruption and when the canal towpath is closed provide a fully signed diversion route

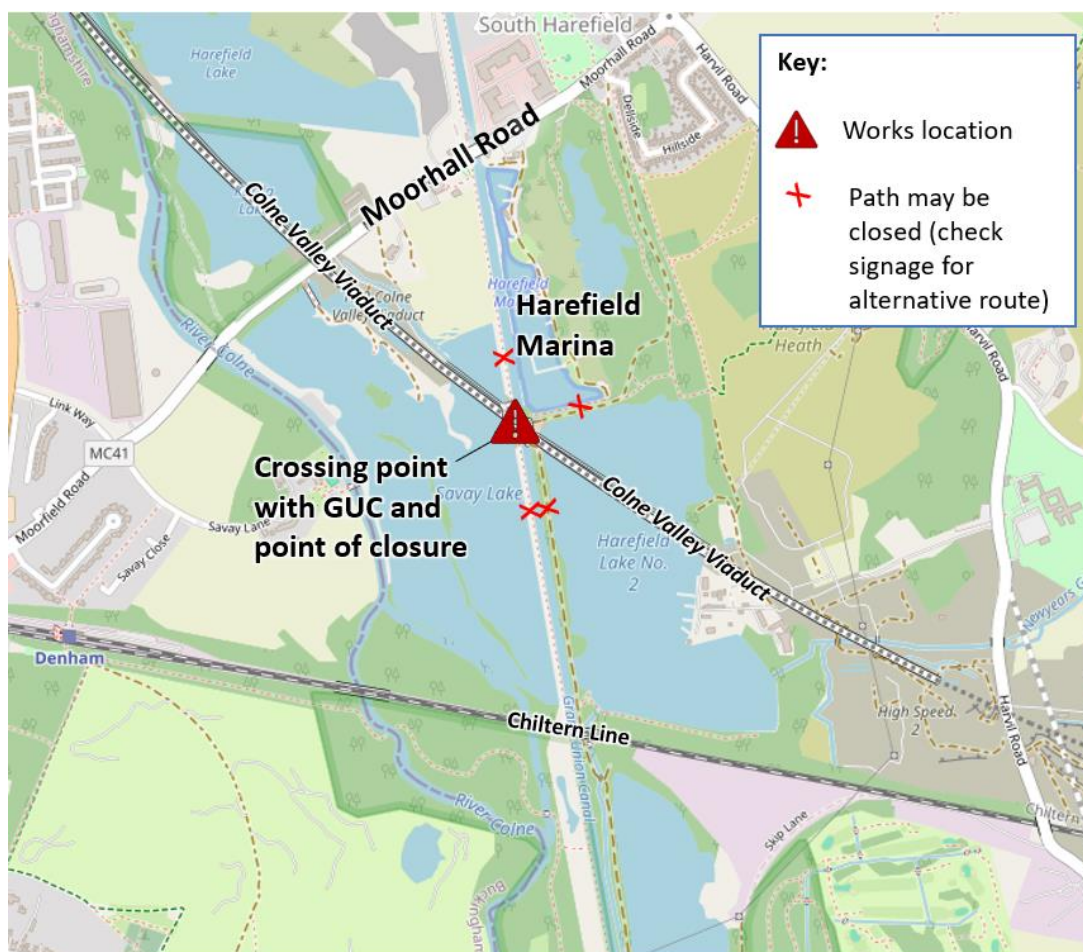

## Timescales

Works will start at 8am on Thursday 1 February 2024 with the closure of the Grand Union Canal and towpath for five weeks following by the reopening of the canal during daylight hours in mid-March, but there will be nighttime closures ongoing until April 2024. We will ensure stakeholders are kept updated, including users of the canal towpath and London Loop. All dates may be subject to change due to cold weather conditions.

## Area of canal closure

Below is a map of where the launching girder for the Colne Valley Viaduct will cross the Grand Union Canal. Pedestrians and cyclists accessing the canal towpath and London Loop via Moorhall Road or Denham Country Park are advised to check signage at the access points to the north and south of the closure point for the latest information on towpath and footpath closures.

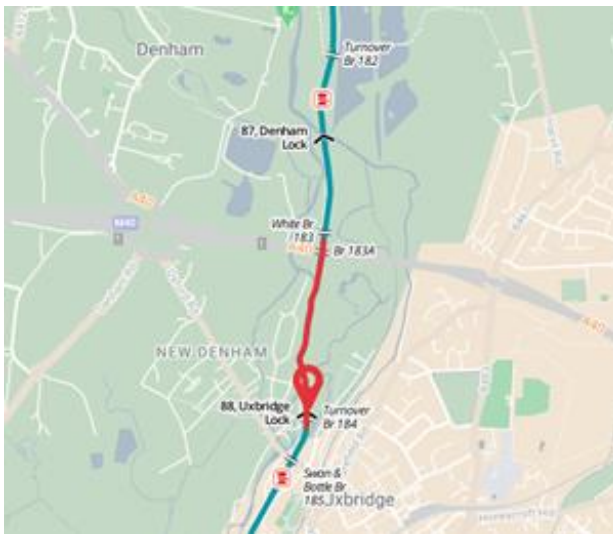

## Lock 88, Top Gate, Uxbridge

A stoppage will be in place at Uxbridge Lock 88 on the Grand Union Canal between Monday 29 January and Friday 1 March 2024. This is to replace the bottom end mitre gates and brickwork repairs.



## Lock 76, Cassiobury Park

Lock 76 on the Grand Union Canal at Cassiobury Park, Watford, will be closed between Monday 12 February and Friday 23 February 2024 as the lining on the top gate of the lock needs to be refitted.
