Re: Lets create the best green corridor around any city in Europe

The countryside on the edge of London is crucially important for people and wildlife. The Colne Valley Regional Park, covering 110km2 on the edge of London and four counties, is nationally important for wildlife and regionally important for people.

However, recent changes to the National Planning Policy Framework (NPPF) threaten the Colne Valley Regional Park and other areas like it, but we believe these threats also present us with the opportunity to create one of the best-managed and best-connected green corridors around any city in Europe. We welcome the Government's statements in its recent planning reform working paper *Development and Nature Recovery* about creating a 'win-win' for both development and nature.

However, this admirable aim is yet to be underpinned with the right ingredients needed to create deliverable policy. In fact, the changes to the NPPF made just before Christmas, significantly weaken the protections for the Colne Valley Regional Park and fail to put in place sufficient tools to achieve the beneficial results the government calls for.

Over the last few years, the situation has become steadily worse in this particularly fragile area of Green Belt and the mechanisms for effective improvement of what remains not yet in place. In our view, the bald truth is that if no action is taken by the Government and local authorities, the Regional Park will not have a future.
